Booking Conditions

A payment of £200 is required to confirm a booking. A provisional booking can be made by email, telephone or by letter and shall be held for 10 days becoming a confirmed booking on receipt of a £200 deposit. ***The rental balance, plus a £100 deposit per week of stay against damages, electricity and oil consumed, must be paid no later than six weeks before arrival date.***

In the event of a cancellation within six weeks of the booking dates the deposit shall be forfeit unless the property is successfully re-let, in which case a full refund shall be given.

The electricity and oil meters will be read before your arrival and on your departure. On completion of the occupancy, if there are no damages, the deposit, less the cost of oil and electricity, will be refunded paid electronically or by cheque within 10 days of your departure.

The cottage will be cleaned and ready for occupation by 3pm on the day of arrival and we request departure by 10:00am on the final day of the booking. It is requested that the property is left in a similar condition.

All breakages should be reported to the housekeeper (Mary Taylor) and the hirers shall be responsible for making good any damage or loss caused to the property and/or contents during, or as a result of their occupancy.

The hirer may bring up to 2 dogs by prior arrangement (3 if very small dogs). The hirer is solely responsible for such animals. The cost of any damage or additional cleaning associated with your dog(s) will be deducted from your refundable deposit. Dogs must not be allowed on the furniture and must not go upstairs at any time.

For the enjoyment of the cottage by all our visitors we operate a NO SMOKING POLICY within the house.
